CYBERSECURITY: Digital Forensics for First Responders

This 8-hour course is designed as an introduction for first responders (officers, investigators, and supervisors) who have basic computer skills and have a need to learn the basics of identifying, preserving, and collecting digital evidence.

Course Objectives:

Course content is designed to simulate criminal situations and test the student's ability to complete a successful forensic image of digital evidence. The course will prepare the student for future classes in the field of digital evidence and computer forensics.
