Class Title: CAL FIRE-Surf Rescue Operations (40-hour)

Dates: March 11th – March 15th, 2019

Times: 08:30 – 17:00 each day

Class Description: **Must be Agency / Department Sponsored.** This course consists of lecture and arduous manipulative skills. Successful completion requires the student to be in top physical condition. Students must pass a 500m Open Water swim test in 12-Minutes or less on the first day to continue. Surf Rescue Operations is a 40-hour introductory course designed to provide the student with the confidence and skills necessary to work in a surf and ocean environment. Basic skills involving equipment, resources, and procedures will be taught to effectively perform a basic surf rescue.
